The Section 7(b) of the Sharda University Act provides as under:

7. The University shall have the following powers, namely:-

(b) to impart and promote the study of Science, Engineering and Technology, Bio and Medical Sciences, Dental Science, Pharmacy, Management, Hotel and Hospitality Management, Law and other professional courses and also History, culture, Commerce, Economics, Humanities, Philosophy, art, etc. through in campus, off campus, offshore-campus and satellite centers or by conducting centers or by distance educational programs.

The UGC has already empowered the University to award degrees under Section 22 of UGC Act 1956.

Now, it is proposed to start a new course **Diploma (Clinical Medical Practice), B.Sc (Cardio vascular Technology) & M.Sc. in Pharmaceutical Sciences with specializations in 1. Pharmacology 2. Drug Design & Development 3. Pharmacovigilance and Pharmacoepidemiology**, in School of Allied Health Sciences from the academic session 2017-18. The proposal of establishing a new course needs approval of the Academic Council of the University. As the meeting of the Executive Council is not scheduled to be held in the near future, the Chairman, Academic Council, is requested to grant his approval for starting **Diploma (Clinical Medical Practice), B.Sc (Cardio vascular Technology) & M.Sc. in Pharmaceutical Sciences with specialization in 1. Pharmacology 2. Drug Design & Development 3. Pharmacovigilance and Pharmacoepidemiology** in School of Allied Health Sciences from the academic year 2017-18.
