Respected Sir,

In view of a representation submitted by the students of Bachelor of Optometry, wherein these students have requested that no fees should be charged for the 4th year, & subsequent to detailed discussion with Director Of Admissions, Sharda University, a meeting was held on 30.07.2018, attended by the following-


- 1) Dean, SAHS
- 2) Head of the Department ophthalmology (SMS&R)
- 3) OSD Medical Wing
- 4) Administrative Officer, SAHS.

Students demand was discussed in light of some observations in the courses conducted in SAHS.

1. B. (Optometry) has course duration of 4 years; the final year includes internship of six months, besides clinical course. Some of the students also opt for internship other than Sharda Hospital. The student of the course pays fees for 4 years.
2. B.Sc (Medical Lab Technology) has a course duration of 3.5 years (3 years of teaching and 6 months of internship). And student of the course pays fees for 3 years (no fees is charged for the internship duration).
3. It is suggested that with regard to B. (Optometry) the student demand of a waiver in fee for the internship period on the analogy of the above referred courses may be considered, if possible, within the rules and regulations of the university.
4. Head of the Department, Ophthalmology (SMS&R) suggested that only viva and internal assessment should be conducted for the students after the completion of the internship & it is proposed that HOD Opto will restructure the evaluation scheme of students of Bachelor of Optometry, fourth year & Dean SAHS will submit the same for approval to the concerned. However, the present batch of students in fourth year shall have the examinations as per the present evaluation scheme.

5. International students : in the courses of B.Sc (Medical Lab Technology) and B. Sc (Medical Imaging Technology) both with duration of 3.5 years (3 years of teaching and 6 months of internship). But the council in their respective countries demands a graduation to be of 4 years.
6. In such cases it is suggested that international students be given additional 6 months of internship, making the course duration 4 years.
