

Background:

Dean, SAHS apprised the members about the request received from Prof. P.K. Mitra to start four Vocational Certificate Courses as given above and from the Director Admission Cell to start a Master Program in Physiotherapy (since two batches of BPT have already passed the final year examination in the year of 2012-13 and 2013-14, we are in a position to prepare ourselves to start a Master Program in Physiotherapy) and to start two new vocational Bachelor level programs in the area of Occupational Therapy (Bachelor of Occupational Therapy) and Rehabilitation Science (Bachelor of Rehabilitation Science). Besides in the last Academic Council a new program of Bachelor in Optometry and Ophthalmic Technique (BOOT) was approved as three years course. However, later on Registrar pointed out that the nomenclature and duration of all courses should be as per UGC guidelines and asked to modify the BOOT course to B. Optometry and duration and Syllabus/Scheme of the Examination be redesigned to bring it as a four years program and submit the same for approval by the Academic Council in future.

In the above background a meeting of the Faculty Board of SAHS was called on 19-11-2014 to deliberate on the Course Contents, Syllabi/curriculum and the Scheme of Examination prepared by the concerned faculty members of SAHS related to the above courses.
