- Dean mentioned the meeting was regarding the revised MDS course regulations for the session 2018-19 onwards. The exam pattern has been modified as per DCI guidelines (MDS Gazette) - vide reference no. DE-87-M2-2017/13.09.2017 **{Annexure-1}**. Henceforth, the same has to be implemented for all the MDS courses which includes –
 - Oral Pathology and Microbiology
 - Prosthodontics including crown and bridge
 - Conservative dentistry and Endodontics
 - Oral and Maxofacial Surgery
 - Periodontology
 - Orthodontics and Dentofacial Orthopeadics
 - Pedodontics and Preventive Dentistry
 - Oral medicine and Radiology
 - Public health Dentistry
- Dean also reinforced that the BDS program will be continued as it is which has been in recognized and approved by both the DCI (vide reference no. DE-130-2011/B-2211/26.08.2011) **-{Annexure-2}**, as well as Academic Council (vide item no. 9.4 c/ 4.12.2014)- **{Annexure-3}**.
- All the heads of the various departments unanimously agreed upon the same. It was decided that the same will be forwarded to the Academic Council for their approval.
