
Amal Kumar, Registrar, Sharda University *and* Member Secretary of Academic Council.





Item No. 14.5: *Considered a proposal received from School of Education for revision of the Course Structure and Credit distribution (Semester 3 & 4) of two year B.Ed. programme offered by School of Education to the students admitted in Academic year 2016-17 and onwards;*

The Academic Council approved the following recommendations received from Faculty Board of the School of Education. The details of the course structure are as placed at **Annexure-7**.

The Faculty Board of the School of Education in its meeting held on April 28, 2017, has recommended the following revision in the course structure and credit distribution (Semester 3 & 4) of the two year B.Ed. programme offered by School of Education to the students admitted in Academic year 2016-17 and onwards.



In Semester 3:

The Pupil teacher will spend 14 weeks in some school and 2 weeks at the University during internship.

In Semester 4:

- i. The number of credits of course code EDU202 'Gender, School and Society' be reduced from 4 to 3.
- ii. The course code EDP211 is changed to EDP177 'Understanding the Self' and credits be reduced from 4 to 2.
- iii. The course code EDU209 is changed to EDU150 'Assessment for Learning' and credits be reduced from 5 to 4 with modified syllabus.
- iv. Functional English (ENG103) with 2 credits *and* Functional English Lab (ENP103) with 1 credit to be introduced.
- v. The course code EDU210 is changed to EDU204 and EDU209 to EDU213.
- vi. One new course title 'School Administration and Management' with code EDU205 with credit 4 is added as core course.
- vii. The course code EDU206 of Guidance and Counselling is changed to EDU203.
- viii. Some more elective courses are added as Environmental Education (EDU211), Peace Education & Human Rights (EDU212), Educational Measurement and Evaluation (EDU213), Women Education (EDU214), Adult and Continuing Education (EDU215), Population Education (EDU216), Life Skills Education (EDU217), Health and Physical Education (EDU218).
