Notification

In continuation of earlier notifications reference no. SU/Reg./Notification/2010/005 dated 25-11-2010, SU/Reg./Notification/2014/219 dated 20-09-2014, SU/Reg./Notification/2015/259 dated 21-08-2015 and SU/Reg./Notification/2016/304 dated 09-08-2016, it is reiterated as under:

- I. 'Prohibition of Smoking in Public Places Rules, 2008' places all Educational Institutions, Hospitals, Auditoriums, Open Stadia, Work Places, Coffee Houses, etc. under the category of 'Public Places'. The University Campus, as a whole, is therefore a 'Public Place' as per the law.

The Members of the Faculty, Officers, Staff and the Students are advised to strictly comply with the Orders of Hon'ble Supreme Court of India prohibiting smoking in public places and Orders of the Government of India / Government of Uttar Pradesh in this regard.

Any violation of the aforesaid orders / possession of beedi /cigarette/cigar/other smoking devices/ materials and / or tobacco products shall invite a fine of INR 1000 or equivalent in USD on the first instance, to be raised to INR 2000 or equivalent in USD on the second instance. Any further violation will make the violator liable for strict disciplinary action as per the rules of the University.

- II. Consumption and Possession of Alcohol is strictly prohibited.

Anyone found in possession and / or under influence of any alcoholic substance, whether consumed inside or outside the University campus, shall be imposed a fine of INR 5000 or equivalent in USD in the first instance. Any repeat violation will make the violator liable for serious disciplinary action including expulsion/ termination/ removal from the University/ Hostels/ Services.

- III. The University has Zero tolerance for possession and use of Narcotics substance(s) and banned drugs.

Anyone found in possession and/ or under influence of any Narcotic substance or banned drugs shall be expelled summarily from the Hostel/ University/ Services as well as FIR will be registered with police, if found necessary.

The Members of the University Community are requested to inform any violation of the above in confidence to the Security establishment / Dean of Students' Welfare / Dean of the Schools (in case of students), Vice-Chancellor or the undersigned. The identity of the person providing authentic information shall be kept confidential.

Co-operation of one and all is solicited.
