#### **Notification**

# Subject: Information regarding Hostel Allotment & Payment of Hostel Fee (applicable to continuing students for the Academic Year 2024-25)

Students of Sharda University are hereby notified that the information regarding the hostel room allotment process, to be done ONLINE through a portal (hostel.sharda.ac.in) and applicable hostel fees for continuing students are as follows:

- Guidelines for Allotment of Hostel Accommodation and Hostel Fee for Continuing Students (excluding MBBS, MD & MS of SMS&R): Enclosure-1
- Guidelines for Allotment of Hostel Accommodation and Hostel Fee for Continuing Students of MBBS, MD & MS of SMS&R: Enclosure-2
- Guidelines for Allotment of Hostel Accommodation and Hostel Fee for Continuing International Students: Enclosure-3
- Students of SMS&R and SSNS&R opting for hostel accommodation may contact IHA authorities for allotment as their programme commencement schedule differs from other Schools of the University.
- Students staying in hostels must vacate the hostel room within three days of the last End-Semester Examination (ESE) of current Academic year 2023-24.
- Hostel rooms to the continuing students will be allotted strictly on the basis of:
  - (i) Merit of the student in preceding End Semester Examinations (ESE).
  - (ii) Availability of rooms in a particular Hostel.
  - (iii) Student's conduct; involvement in any act of indiscipline or any other reason like debarment due to non-payment of dues.
- Registration of hostel room by a student merely does not guarantee allotment. The University reserves the right to give preference to deserving students.
- Students can submit hostel fee through online mode as provided on hostel website within the due dates of submission.
- Security amount of Rs 10,000/- for Non-AC category and Rs 20,000/- for AC category respectively from students seeking hostel room accommodation for the first time. This will be charged in addition to the hostel fee.
- In case the students find difficulty while processing payments through gateway provided on hostel website, students have other options of making hostel fee payment, wherein the student can:
- (i) Submit hostel fee, along with the duly filled form, directly to the Accounts Department of the University. The fee can also be paid through online mode, please refer to <u>https://www.sharda.ac.in/payment-procedure.html</u> (except Vardhman Hostel).

(ii) For payment towards Vardhman Hostel shall be made in favour of 'V.S. INSTITUTE & HOSTEL PRIVATE LIMITED' The bank details for online payments are as below:

- (iii) IHA will consider the hostel allotment registration form, only if the hostel fee is paid in the specified University accounts and is within the due dates of submission. The payment receipt must be attached along with the application form while submission. Hostel requisition form can be collected from IHA Office only.
- Failure to pay hostel fees by the due date as mentioned in schedule of payment will attract imposition of late fee fine. Attention in this regard is drawn to Notification No. SU/Reg./Notification/2022/027 dated 30th April, 2022 in this regard. Enclosure-4
- Students on obtaining prior written permission from IHA are permitted to install/use electrical
  items in their rooms by paying electricity charges. Details of electric equipment permitted and
  charges payable are described below. Anyone found using electrical items in their room without
  making permission from the authorities will have to face disciplinary actions and a fine as
  determined by the management.
  - (i) Room-cooler may be permitted in the room by paying the following electricity charges.
  - (ii) Rs.7,000/- per student for single seater room,
  - (iii) Rs.5,000/- per student for two-seater room and
  - (iv) Rs.3,000/- per student for three-seater room for one summer season
  - (v) A Refrigerator (maximum capacity of 80 Ltr.) may be allowed on payment of electricity charges Rs 6,000/- per annum.
  - Electric Kettle of 1200 Watt capacity may be allowed on payment of electricity charges of Rs 3,000/- per annum.
- Complimentary Laundry service, 8.0 kg x 20 washes, will be available to all the Hostel residents.
- Upon receiving request from students, the hostel authorities may change the room category specified by the student, depending on availability; however, on room changing the student must accept the room partner assigned by IHA in the revised allotment.

#### Summer Term Charges

For 2nd year onward students, who are appearing in Summer Term Examination and are in requirement of hostel accommodation during the summer break in the month of June & July 2024, then in those cases:

- (i) Hostel Accommodation may be allotted as decided by IHA office on payment of fixed charges of Rs. 5,000/- per month for Non-AC and Rs 10,000/- per month for an AC Room.
- (ii) The charges for day scholars seeking hostel accommodation during summer break in the month of June and July 2024 shall be on pro-rata basis including hostel security (as applicable) as per the hostel charges for the Academic year 2023-24.
- (iii) International Students on scholarship will be provided with an alternative accommodation during summer break, duration which runs from June 1, 2024 to July 31, 2024 based on the recommendations of International Relations Division (IRD).

- (iv) International student who have paid complete hostel fee during the academic year 2023-24 in USD will be charged USD 100/- per month for Non-AC Room and USD 200/- per month for AC Room from the students including non-veg meal charges.
- (v) During the summer break period, AC and Non-AC rooms will be allotted depending on the AC/Non-AC categories availed during the previous academic year.

Should there be any clarifications or difficulties encountered while entering the fields in the online process, the students may contact IHA staff during office hours.

## How to Login Sharda Hostel

**STEP – 1:** Visit the Sharda Hostel website using the following link: <u>http://hostel.sharda.ac.in/login</u>. After clicking on the link, you will be redirected to the Sharda Hostel website. You will see a screen that looks like this:



**STEP – 2:** <u>Student Login:</u> If you are a student, you need to enter your system ID provided by Sharda University and click on the 'Send OTP' button. After clicking the 'Send OTP' button, you will receive an email at your registered email address.



Once you receive the OTP on your registered email address, enter the OTP password or OTP input

After entering the OTP, click on the 'Sign In' button. Once you have signed in on the website, you will see a screen that looks like this:



Note: Students whose system ID starts with '2024', 'Students of SMSR' and 'SUSNR' students are not eligible to log in to the hostel portal. In this case, such students must book their room through the IHA department.

**STEP – 4:** After clicking on the Hostel Booking Box, a window will open. Prior to proceeding, we will check student CGPA and SGPA. If student is a first-year student, we will assess student's SGPA, whereas if student is a second-year or higher student, we will review student's CGPA. If student's CGPA or SGPA is below the allowed hostel booking CGPA/SGPA, a window similar to this will open:

If any student is categorized as being in the category of indiscipline, then when they click on the hostel booking window to book accommodation, they will see a message like this and will not be considered eligible to book the hostel.



If student's CGPA is higher than or equal to the allowed hostel booking CGPA/SGPA, a window similar to this will open.

- b) After selecting the meal type, students will be able to view the hostel fee of the selected hostel.

## **Notification**

### Sub: Penalty for late Registration, late payment of Fees, Hostel and Transport charges, etc.

In supersession of all the previous notifications on the cited subject, the following penalty charges will be effective from the academic year 2022-23 on account of late payment, provided as under:

- A. Penalty for late Registration:
  - i. The penalty for late registration shall be a minimum of ₹2,500.
  - ii. Late registration, beyond three days from the last date of registration, shall entail a penalty of ₹2,500 + (₹100 × number of days). Such late registration, up to a period of one week, may be allowed with the approval of the Dean of the School.
  - iii. Depending on the merit of each case, the Registrar may permit, after the aforesaid one week, late registration on payment of late charges.
  - iv. NO REGISTRATION shall be allowed after two weeks from the last date of registration.

Unless payment of all the dues are made, no student shall be registered and his/her attendance will be not recorded. Further, the internal assessment and examination marks shall also be not uploaded unless the registration is made.

- B. Penalty for late deposit of fee:
  - i. The penalty for late deposit of fee shall be minimum of ₹2,500 for the first week.
  - ii. Thereafter, penalty @ 1.5% per month shall be charged, calculated on daily basis, for the further delayed period of payment.
  - iii. In cases where more than 90% of the tuition fees is paid on or before the due date, no late fee charges shall be payable.
- C. Penalty for late payment of Hostel charges:
  - i. The penalty for late deposit of hostel charges shall be minimum of ₹2,500.
  - ii. Additional penalty @ 1.5% per month shall be charged, calculated on daily basis, for the delayed period of payment.

#### D. Penalty for late payment of Transport charges:

- i. The penalty for late deposit of transport charges shall be minimum of ₹1000.
- ii. Additional penalty @ 1.5% per month shall be charged, calculated on daily basis, for the delayed period of payment.

#### E. Penalty for dishonor of cheque:

In case the cheque deposited by a student towards payment of any fee/penalty charges gets dishonored or bounces due to no fault of the University, penalty at a flat rate of ₹1000 shall be imposed.

- 2. In very exceptional circumstances depending on the merit of a case, the Registrar may, at his discretion, consider reduction/waiver of the penalty/fine levied under these rules.
- 3. These provisions will, however, be not routinely applicable in cases where the students have been sponsored by the Central/State Government, or by foreign governments in respect of international students. In such cases, the Registrar will take a final decision, keeping in view the facts and circumstances of each case.
- For the purpose of calculations, the amount of late fee/arears may be rounded off to the next ₹100 or USD 1.
