Point 2: Briefing of NAAC activities

Director IQAC briefed the different activities done in the 1st quarter of academic session 2019-20. The following activities are reported.

- A. Earlier it was decided that University would go for reassessment. Accordingly IIQA was submitted and got approval on 18th September 2019.
- B. IQAC conducted three mock visits by external NAAC Experts in the month of July, August and September 2019.
- C. Gap analysis has been made based on the report submitted by External Experts.
- D. It is found that lot of improvement is needed for NAAC.
- E. It is decided not to go for reassessment.
