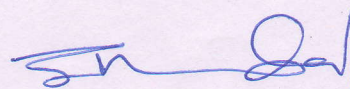

Point 5: NAAC Mock drill

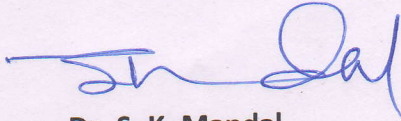
It has been decided that 2-3 NAAC mock drill to be conducted by external peer team experts before submission of final NAAC SSR for re-assessment.

Point 6: Preparation for QS-iGauge rating

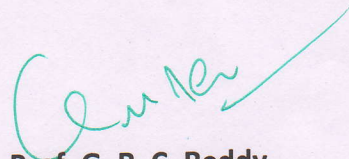
It has been decided University should apply QS-iGauge rating.
