NOTIFICATION

Subject: Enhancement of Fellowship and Contingency grant for Full-Time Ph.D. Scholars - regarding

The notification no. SU/Reg./Notification/2019/216 dated September 1, 2014 was issued in reference to the Fellowship-cum-Assistantships for Full-Time Ph.D. Scholars.

To enhance the motivation for Ph.D. Scholars in research areas, the 'Fellowship for Full-Time Ph.D. Scholars' of Sharda University is hereby notified to all concerned.

The Full-Time Ph.D. Scholars of Sharda University will be eligible for the award of the Fellowship-cum-Assistantship, as per the criteria mentioned below:

- i. Fellowship-cum-Assistantship shall be awarded only to the full-time Ph.D. Scholars based on admission and proof of having taken and received a score in NET *or* score with validity in GATE *or* in similar other examinations accredited by University Grants Commission (UGC). Candidates without such scores will be awarded fellowship as per existing amounts of Rs.18,000/- Rs. 19,000/- Rs. 20,000/- per month for a maximum period of 3 years, but under the conditions as per the present notification.
- ii. Selection will be made through the merit list of the entrance test and the cutoff for the fellowship will be made on the basis of number of fellowships available in the respective departments.
- iii. The amount of fellowship cum assistantship will be Rs. 25,000/- per month for first two years and Rs. 27,000/- per month for the third year. Third year fellowship is subject to publication of at least one paper in Scopus indexed journal. The University will withhold Rs.10,000/- per month till Research Plan is approved and then release the amount subject the condition of completion of course work within one year of admission.
- iv. University will create a corpus fund @ Rs. 5,000/-per month per research scholar as contingency amount for utilization towards promotion of research in the University. This amount can be utilized for purchase / fabrication of equipment, maintenance / repair of existing equipment, purchase of consumables, purchase of books for library, expenditure related to attending conferences etc. All the expenditure should follow Sharda University financial rules and be approved by Dean, Research on the basis of justification and recommendation of the purchase committee chaired by the Dean and convened by the Head of Department of the respective school from where the proposal originates.
- v. A teaching assistantship is an integral part of the fellowship. Head of Department/ Dean may assign teaching load up to 8 (eight) hours per week and academic administration work up to 4 (four) hours per week.

- vi. The progress of the research work shall be monitored by Doctoral Committee (DC) for the scholar and the School Research Committee (SRC) once in every six months. Fellowship-cum-Assistantship shall be renewed based on satisfactory progress and recommendation of the DC and the SRC.
