Subject: Accreditation status of UG Pharmacy program applied by Sharda University, Plot No. 32, 34, Knowledge Park III, Greater Noida, Uttar Pradesh 201310.

Sir,

This has reference to Appeal dated 27-02-2025 filed by Sharda University, Plot No. 32, 34, Knowledge Park III, Greater Noida, Uttar Pradesh 201310 against the decision of NBA granting accreditation status "Not Accredited" to their UG- Pharmacy program, communicated vide NBA's letter of even number dated 03-02-2025.

2. The Appeal was considered by the Appellate Committee of NBA in its meeting held on 24-09-2025. The Appellate Committee recommended re-evaluation of UG-Pharmacy program by conducting re-visit to Sharda University, Plot No. 32, 34, Knowledge Park III, Greater Noida, Uttar Pradesh 201310. An NBA Team conducted onsite evaluation of the program from 9th to 11th January, 2026. The report submitted by the Visiting Team was considered by the concerned Committees constituted for the purpose in NBA. The Competent Authority in NBA has approved the following accreditation status to the program as given in the table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to Sharda University, Plot No. 32, 34, Knowledge Park III, Greater Noida, Uttar Pradesh 201310 as a whole. **As such the Institute should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously. Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, as well as the date from which the accreditation is effective, should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.**



If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.

8. If the Institute is not satisfied with the decision of NBA, it may appeal within thirty days of receipt of this communication on eNBA portal alongwith Report of the Expert Team, giving reasons for the same and by paying the requisite fee.
